Summary of the purposes of the charity as set out in its governing document	Para 1.17	The Objects of the charity are to promote any charitable purpose for improving and developing the artistic creative talent of the young people, in particular but not limited to, aged 8 to 26, in particular but not limited to financing coaching in the Arts and any other activity which the trustees see fit in pursuit of the organisation's purposes, including mentoring, performance opportunities and the promotion of equality and good mental health through access to the Arts for those that would not be able to afford under normal circumstances.
		Campden Edge's geographical limits are defined as the district of Campden Vale and the surrounding villages of Blockley, Paxford, Stretton on Fosse, Pebworth, Honeybourne & Aston Magna; and including current and past pupils of Campden Schools who fall outside the areas defined above.
		Please note: On 28 February 2021, we gained the Charity Commission's approval to revise our Objects inserting the words <i>"in particular but not limited to"</i> before the age definition of 8 to 26. Our charity is focused on 8-26 year olds however sometimes a school applies for financial support which includes family groups or which includes a section of the school not covered by this specified age range, for example, a whole school theatre trip or a whole school workshop. We believe that in these circumstances the charity should financially support the younger children as well as this is in the spirit of our main charitable object. The revision was ratified at our AGM in May 2022.

Para 1.17 and 1.19	Our main activity is to raise funds via events, general publicity, and collection boxes. We receive monies from individual donors, local groups, and other charitable trusts. We are all volunteers and we aim to keep overheads to a minimum so that the majority of money raised can go towards supporting individual applicants and schools.

Our envelope campaign which ran for 4 evenings during the Chipping Campden Music Festival in May 2022 which raised £1626.68 (including a £500 donation from the ND Cadbury Charitable Settlement); and we were also the joint beneficiaries of The Campden Open Gardens weekend which ran in June and which raised £2,672 for us.
		We received support from various organisations and trusts amounting to £683 excluding £500 from the ND Cadbury Charitable Settlement previously mentioned and £500 from the RL Charitable Trust.
		In addition, the charity has collection boxes across the area which brought in a total of £119 – as opposed to £144 last year.
		The charity made grants totalling £9,714 to pay for arts education for 42 individual students (as opposed to £8,762 for 24 students last year).41 for music lessons and 1 student for drama school. We also made general school grants of £1,431. In total we made grants of £11,145.

Schools Support

Trustee, Sara Wright, runs the Schools Support scheme whereby the schools (7 primary and one secondary) in our catchment area can apply for funding for arts-based extra curricula trips to support students whose family cannot afford to pay for the cost of a trip or event. The grant totals £1,431 across the 8 schools for the year. Schools have been contacted via email and telephone call during the last year. This ensures schools are aware of the scheme, remind them of Campden Edge (and what resources we can provide), and enables us to build up contacts within school who will often refer teachers/families to us. 	lessons or ideas for sponsorship to consider. In the last year three primary schools approached us to request grants to help purchase tickets for two theatrical performances and three workshops. This scheme funded 89 places and helped 71 children.
	Instrument Library.
	The charity runs a small virtual instrument library where unwanted instruments can be placed with students. Since March 2022, a keyboard; 2 cellos; 2 guitars; and 2 French Horns have been placed.
